

## Make Black Lives Matter

Do Black lives matter? There's a question that can't be asked out loud these days. But I'll ask it anyway. I look around me. I look at my Black friends that I have worked closely with over the years—the Haitian and Charter School communities—and I am forced to keep asking: Do Black lives matter? And, if so, to whom? And rather than answer that question, I will offer the thought that, if the Black community truly wanted Black lives to matter, they would take the following Make Black Lives Matter steps:

First, and foremost, and cheapest, and most obvious, is Vote Republican. Sure, you say, I'm just being a partisan hack. Not true. I'm being a realistic observer. As Charles Barkley has said many times: "Blacks have been voting for Democrats for fifty years and they're still poor." And the beauty is, it's the easiest thing one could ever do. Same election day, same polling place, same ballot; the only difference is going straight down the R line instead of the D line. There is no one thing the Black community could ever do to effect greater benefits for such minimal effort.

The next best thing, especially for inner city Blacks, is to get their Concealed Weapons Permits. Yes, it takes some effort and some money. There's a three-hour course, a three-bullet practice session and a trip to the state licensing office. It's well worth the time and money. The benefits are greater than one can imagine. Armed responsible inner-city residents are the greatest deterrents to crime. The bad guys know this. They never want to prey on people who will fight back. And, as an added bonus, reduced crime means increased home values. You can take it to the bank, literally.

Moving on, it's time to save the children. Let the White Liberals save the whales. Black, inner-city residents have real problems. The easiest way to save the children? Enroll them in charter schools, or, if your state allows it, apply for opportunity scholarships. But whatever you do, get your kids out of the inner-city government schools. Now! Your children deserve better than a lifetime of reading below grade average. And your down-the-street charter school is the ticket. Go from punching-the-clock administrators to answering-the-call faculties. Never forget, the government school's teachers give a piece of their paycheck to a union committed to keeping Black families from having "School Choice." Stop funding the opposition. Start fighting for your own kids.

These are three easy, inexpensive, life-changing suggestions. The benefits would accrue almost immediately. There are two final pieces to the Make Black Lives Matter program. Both are difficult, expensive and time consuming. Both extend beyond helping a family and go to reviving a community.

The first? End abortions. Okay, you don't have to end all abortions, just the ones that terminate Black lives. After all, it's hard to imagine that Black lives matter to those cheering about the one thousand Black abortions every day, three hun-

dred sixty-five days a year. Since *Roe v. Wade* in 1972, there have been more than twenty million Black babies aborted. What can Black families do? Go back to the first suggestion. Replace your Black Democrat congressman with a Black Republican congressman. That alone will save the children. But it will take more than one vote, one time. It takes organizing, lobbying, fundraising and candidate recruitment; the whole gamut of political activism. It takes education about Planned Parenthood, its eugenicist founder, Margaret Sanger, and the very big business of Black abortions.

"There isn't enough money on the planet to save a community without fathers." That's one of my most favorite, and most true, soundbites. It's in my 2008 book, *Adults Only*. In the 1950's, 85 percent of Black children grew up in two-parent families. Today it's less than 25 percent. It's more than a crime. It's a sin. Blame Lyndon Johnson and his War on Poverty. Financial incentives were offered to poor (mostly Black) mothers if they refused to get two things; a husband and a job. Enough said. This final piece of the Make Black Lives Matter agenda is the one that brings stability and permanence. It's the solution to all the problems of all people of any race. It's the foundational cornerstone of success and upward mobility. The two-parent family is the gift that keeps on giving.

So here we are, back to our original question: Do Black Lives Matter? And the answer is "No" and "Yes." It's "No" if you think that taking a thousand knees or toppling a thousand statues will improve a single Black life. It's "Yes" if my Make Black Lives Matter agenda is taken seriously by Black America. The good news? It's a question only the Black community can answer. The better news? It's on the ballot this November.

### WHY THE UNITED STATES IS NOT A “SYSTEMICALLY” RACIST COUNTRY AND WHY IT MATTERS

July 4, 2020—First, let us examine the word “systemic,” because as Mr. Obama said, “words matter.”

In medicine, systemic means, “affecting the whole body as opposed to only parts of the body.” Other words for systemic are “complete,” “extensive,” or “universal.”

So, is the United States completely, extensively or universally racist? By any objective standard the answer is obviously “no.” But that is what the Democrat-Marxists want you to buy into. Why? Because, once you buy into the notion that we are a “systemically” racist society, then nothing is sacred, nothing is worth preserving. And then the slippery slope of destruction begins.

This is in line with the Marxist agenda of the “fundamental” transformation of America. Before something can be fundamentally transformed the people must be convinced there is little or nothing worth saving. Hence, if the United States is a “systemically” racist country, there is nothing worth preserving in our past and it all must be destroyed. That is their goal. And this is exactly what we have been witnessing in recent months and weeks.

So, this post refutes the notion that we are a “systemically” racist country. Rather, we are a country very much worth saving.

#### The Ideal

The analysis begins with our Declaration of Independence penned in 1776. Our founders avowed, “We hold these truths to be self-evident, that ALL men are created equal . . . endowed by their Creator with certain unalienable rights. . . .” The Ideal was penned, the standard to strive for was set.

What follows is a summary of 160 years of American history. It reveals a continuous and concerted effort from 1860 through 2020 to make that Ideal a reality for all Americans.

#### Our 19th Century

In 1860, Abraham Lincoln, the first Republican President was elected. Within a year, America is embroiled in our great Civil War. At least 618,000 soldiers died in the conflict. More Americans died in battle from 1861 to 1865 than in any other American war before or since, including World War II.

There are some who call for slavery “reparations.” In response I ask, aren’t 618,000 dead Americans and an assassinated president enough?

Our nation literally tore itself apart to end the horrible practice of slavery. In 1863, 51,000 men died in one battle

alone in the foothills of Pennsylvania, a place called Gettysburg. It was the costliest battle in U.S. history.

Abraham Lincoln dedicated a portion of that battlefield with these words:



Four score and seven years ago our fathers brought forth on this continent, a new nation, conceived in liberty and dedicated to the proposition that all men are created equal . . . that we here highly resolve that these dead shall not have died in vain—that this nation, under God, shall have a new birth of freedom—and that government of the people, by the people and for the people, shall not perish from the Earth.

Two years later, the XIII Amendment to the Constitution was ratified, abolishing slavery. That amendment marked the end of the war but the beginning of our struggle to live up to our Ideal.

In 1868, the XIV Amendment was ratified, making it illegal to pass any law abridging any freedoms now given to all citizens.

The work was not finished.

On February 3, 1870, the XV Amendment to our Constitution was ratified, prohibiting any state from denying any citizen the right to vote “on account of race, color, or previous condition of servitude.” America prospered thereafter but southern segregation and “Jim Crow” laws became common in the South.

#### Our 20th Century

WW I, the Great Depression and WW II intervened but in the 1950’s, it was time for America to deal with racial inequality again and to continue our journey in living up to our 1776 Ideal.

In 1954, the U.S. Supreme Court in *Brown v. Board of Education* unanimously ruled that racial segregation of children in public schools was unconstitutional. Thurgood Marshall was the lead attorney for the plaintiff. Thirteen years later, in 1967, he would become the first Black Supreme Court Justice.

In 1957, when the state of Arkansas tried to prevent nine black students (who became known as the “Little Rock Nine”) from entering an all-white school, Republican President Dwight D. Eisenhower sent 1,000 U.S. Army troops from the 101st Airborne Division to insure that Little Rock Central High School was integrated.

In 1964, Congress passed the Civil Rights Act, ending discrimination in public places and in employment. It is a historical fact that a greater percentage of Republicans voted for the Act than Democrats (78% of Republicans voted for it, 60% of Democrats voted against it). In fact, the Democrats in the U.S. Senate launched a filibuster that held up passage of the bill for 57 days!

Also that same year, the XXIVth Amendment to the Constitution made poll taxes illegal in federal elections, which had been erected in the south to keep Blacks from voting.

A year later, in 1965, the Voting Rights Act was passed to eliminate other barriers to voting erected by the Democrats in the South.

In 1966 in *Harper v. Virginia Board of Elections*, the U.S. Supreme Court prohibited states from imposing poll taxes in all elections, not just federal.

In 1968, Congress passed the Fair Housing Act prohibiting discrimination in the sale and leasing of residential real estate.

Meanwhile, professional and college sports teams began to fully integrate their sports team's facilities. In 1976, the U.S. Supreme Court weighed in again in *Runyan v. McCrary*, holding that private schools could not deny admission for students based on race.

Thereafter and throughout the 1980's, the concept of "affirmative action" took root, whereby the federal government, large corporations, and colleges and universities would actually give preference to persons of color in hiring and in admission practices.

Between 1983 and 1999, pro basketball player Michael Jordan captivated the nation as perhaps the greatest basketball player who ever lived.

In 1991, Republican President George H.W. Bush nominated Clarence Thomas to be the second Black Supreme Court Justice. Judge Thomas was educated at Holy Cross University in Massachusetts and Yale University Law School. At his Senate confirmation hearing, the vote was 52-48. Of the 48 "no" votes, 46 were Democrats.

Two years earlier President Bush had appointed Colin Powell as the first Black Chairman of the Joint Chiefs of Staff.

### Our 21st Century

Between 1997 and 2008, Tiger Woods revolutionized the game of golf, becoming the most popular professional athlete in all of history, causing record attendance and record TV ratings whenever he took to the links to compete.

President Bush's son, the 43rd President of the United States, appointed Mr. Powell as the first Black Secretary of State from 2005–2008.

In 2008, the United States overwhelmingly elected its first Black President, Barack Obama, who served for eight years, spanning two terms. Under Mr. Obama, Eric Holder served as the nation's first Black Attorney General.

More recently, at the end of 2018, Congress passed, and President Trump signed, "The First Step Act" with overwhelming bi-partisan support. It was the first criminal justice reform bill passed in a generation.

Senator Cory Booker, a Black United States Senator from New Jersey, praised the bill saying, "For the first time in a long time with the passage of this bill into law our country will make a meaningful break from the decades of failed policies that led to mass incarceration . . . and disproportionately harmed communities of color while devaluing the very idea of justice in America."

Does all of this look like the hallmarks of a "systemically" racist society? Of course not. It is the history of a nation striving to live up to its Ideal.

Do inequalities still exist? Absolutely. Our inner-city schools are an example. Republicans have been pushing for "school choice" for parents of inner-city students for years. These efforts have been consistently opposed by Democrat city leaders and the teacher's unions that influence them. But the easy way out is to simply claim "racism!"

Let us stop the name calling and have a civil discussion about real solutions to address specific problems. As to the charge that we are "systemically" racist? I reject that notion.

### Epilogue

What this is really about is far more sinister. Black Lives Matter is an avowed Socialist-Marxist organization, bent on overthrowing the social order to achieve their Marxist agenda. What is terrifying is the big business and the Democrat Party have become willing accomplices in this new civil war.

There is one person who stands in the gap for us, We the People. There is one person standing between your values, your property and your freedom—Donald J. Trump.

On November 3rd we have a choice. We can choose the light and enlightenment of our Declaration of Independence and keep working for our Ideal, or we can watch it all get torn down, while the light of America slowly gets extinguished, until it is no more. What legacy will we leave our children?



## Why Did America's Founders Say . . . "All men are created equal"? (Part 1 of 2)

As a civil rights activist my entire life, I have long supported the of removing the statues, symbols and names that honor the Confederacy and those infamous for racial intolerance—especially those engaged in the remnants of institutional and *de facto* racism that we find today. This does not mean, however, that I favor vigilante destruction of these misplaced monuments, but instead that they be moved legally to more appropriate sites—such as museums—where they can be part of an accurate description of their place in history—infamy, if it be that.

It is important to remember that most of those Confederate symbols were NOT some post-Civil War olive branch. They were not part of President Lincoln's "charity to all and malice toward none" Reconstruction policy. The more charitable post-War treatment of the leaders of the Confederacy came after Lincoln's assassination, when southern Democrat Andrew Johnson assumed the presidency. Johnson's favoritism toward the leaders of the Confederacy enraged those in Congress known as the Radical Republicans—and the excessive leniency of Johnson only ended with the election of Republican President Grant.

But many of the honors—statues, flags and namings—came after Democrats took over the south by force-of-arms in the late 1800s—literally, a mini-civil war against Negroes and the Constitution waged by the Democratic Party and their paramilitary enforcers—such as the Ku Klux Klan, the Red Shirts, the White Citizens Councils and others—for another 100 years.

Other racist monuments arose in the early 1900s during the shameful racist administration of Democrat President Woodrow Wilson—a southern white supremacist with a glowing passion for the Confederacy and an open affection for the Ku Klux Klan. It probably stems from his early years as a child in a Virginia slave-owning family.

And yet another round of Confederate honorings came in the 1960s when the leaders of the solid Democrat southland rose in defiance of integration—especially school desegregation. Under the Southern Manifesto, many of the most prominent and powerful Democrat leaders of the time showed their defiance by adding the Confederate battle flags to a number of southern state standards—where they remained until Republican Governors and Republican legislature began removing them.

But what about folks like George Washington, Thomas Jefferson and all the other American icons that the left has

put in the crosshairs of their radical campaign against the entire American culture? The left accuses President Trump of engaging in a culture war. In reality, it is Republicans, in general, and conservatives, specifically, who rise in defense of a culture based on personal freedom, limited government and equality—a culture upon which THE LEFT has declared war in favor of autocratic principles—including socialism.



Every American should be thankful for the wisdom and goodness of our Founders—and that includes even those who may not—at this moment—enjoy the full share of American Exceptionalism and have full access to the nation's personal

opportunity society. Even those who are still oppressed in our one-party authoritarian Democrat-controlled major cities have greater opportunity and freedom than most people of the world. But much more needs to be done to level the playing field. And thanks to the Founders, the pendulum of history has moved—and is still moving—in favor of the disadvantaged. For sure, the job of rooting out *de facto* racism WHERE IT EXISTS is an incomplete task.

We rightfully honor our Founders for the eminent good they did despite their slave ownership at the time. They crafted a nation that placed unprecedented vast power in the hands of the people—something that was not seen in the world in which they existed—a world of kings, potentates, czars, tsars and tribal leaders. Virtually every nation—and every people—on earth at the time were ruled over by authoritarians. Our Founders were raised, bred and educated in that world—and yet they crafted for America a nation where "we the people" have maximum influence over matters of state—if we choose to protect it and exercise it.

No sooner than they enacted the Constitution to articulate—not guarantee—the inalienable rights of the people, they used their own enshrined amendment process to craft 10 new tweaks to the Constitution to more clearly define our inalienable rights—the Bill of Rights.

The ability to amend the Constitution was incredibly important regarding their thinking on slavery. It was not an institution that most of the Founders accepted with comfort,

Even as slave owners, they longed for the day that some future generation would do what they could not, given the zeitgeist of the times—end slavery. Washington wrote (emphasis added):

*The unfortunate condition of the persons, whose labour in part I employed, has been the only unavoidable subject of regret. To make the Adults among them as easy & as comfortable in their circumstances as their actual state of ignorance & improvidence would admit; & to lay a foundation to prepare the rising generation for a destiny different from that in which they were born; afforded some satisfaction to my mind, & could not I hoped be displeasing to the justice of the Creator.*

Washington expressed his frustration with the institution of slavery on a number of occasions. In communicating with a cousin, he said that he “longed every day . . . more and more to get clear of the ownership of slaves.”

Washington’s last will and testament emancipated a large number of slaves under his authority. He was legally prevented from freeing those slaves he managed on his plantation, but to which he did not personally hold title. They were divided among the grandchildren. A portion of the slaves were left with his widow Martha—to be freed upon her passing. She freed them rather quickly fearing that one among them may take her life to gain freedom.

Thomas Jefferson’s immortal words in the very Declaration of Independence—that ALL men (as in mankind) are created equal with equal human rights—was an extraordinary statement of the times. It was a shot across the bow of those who supported slavery and the inferiority of Negroes—enslaved or free.

Jefferson once described his frustration on the issue of slavery in his day by saying it is like holding “a wolf by the ear; and we can neither hold him, nor safely let him go.” But even as a slaveholder by pragmatic necessity, he—like Washington—had the heart of an abolitionist.

Jefferson often opined against slavery, believing it would lead to the destruction of the Republic—and it almost did. John Adams and John Quincy Adams were outspoken abolitionists and never owned slaves. Most of the Founders expressed either opposition or at least discomfort with slavery.

The second genius of the Founders was their ability to foresee the need for we the people to lead this new union of states to be a “more perfect union.” They gave the people the power to even change the very Constitution they so carefully crafted. Men like Washington and Jefferson not only laid the foundation and the moral case for emancipation, they were—in that sense—abolitionists in heart and mind.

They were exceptional men of the day with extraordinary morality and vision. It is only ginned-up ignorance that has aroused the rabble to attack their memory, their history and the honors bestowed on them by generations of appropriately appreciative Americans. Their sin in the eyes of the left is not drawn from an objective analysis of their, words, actions or deeds, but merely the fact that they are White old men—and the public is susceptible to the left’s fraud because of a lack of education.

You have to remember that the Equality Phrase in the Declaration of Independence was endorsed by all the Founders. From the day it was adopted, it has screamed out against prejudice and white supremacy—or supremacy of any kind based on identity politics. It was the clarion call that led to the abolition of slavery, the end of southern segregation and oppression—and coincidentally gave women and 18-year-olds the vote—and is still crying out on behalf of those currently trapped in our *de facto* segregated cities—the last vestiges of the Democratic Party’s long history of Negro oppression.

If it is wrong to apply cancel politics to such notable Americans as Washington, Jefferson and others, are there those who should be re-routed to less honorable statues? For sure. And I will deal with that in Part 2 of this commentary.

**Trump’s 200 Judges Will Leave Longstanding Legacy**

When President Trump came down the escalator in Trump Tower to first announce that he was running for president a little over four years ago, we heard two main complaints. First, he had no political experience. And second, he was not conservative enough.

Just last month, President Trump hit an astonishing and impressive conservative milestone when the Senate confirmed his 200th judicial appointment. This is a serious strategic move not accomplished since Jimmy Carter. In other words, it’s the first time we’ve filled every single circuit court vacancy in the last 40 years. Of these judges, 53 have been appointed to the influential courts of appeals, the last stop for cases before the Supreme Court, filling 30 percent of its seats with hand-picked conservatives—and these judges aren’t just conservative. They’re also young.

According to an analysis by the Brookings Institution, the average age of President Trump’s judges at the time of appointment is 48 years old. Compare this to President Obama’s appointees at 57 years old, President George W. Bush at 51 or President Clinton at 50 and you understand that these judges are relatively young. Keep in mind that federal judges serve lifetime appointments. These conservative judges will be shaping the law with a constitutional

lens long after Trump leaves office. The America First agenda will last for decades.

But in the present, these newly appointed judges have already made an impact with rulings and dissents on abortion, executive power, healthcare. Many have ties to the conservative legal movement which opposes abortion, as well as onerous environmental and labor protections which respect the free market.

For someone who just entered politics a little over four years ago, President Trump clearly understands the political landscape and is remaining faithful to the Constitution. He’s not just making speeches at rallies, he’s making a measurable impact on the country for years to come. These judges are his legacy and alone should be motivation to vote for the President once again in the 2020 presidential election.

## Congress Opposes Prostitution and Sex Trafficking

Let the title got your attention! But the subject of this article is all about prostitution and sex trafficking. No, it is not about Epstein and his accomplices. It is about what the Congress and President George W. Bush did in 2003. From the six-page majority opinion of the Supreme Court issued on June 29, 2020 by Justice Kavanaugh, here is what the case is all about.

Congress passed and President Bush signed the Leadership Act, 117 Stat. 711, as amended, 22 U.S.C. § 7601 *et seq.*, which provides billions of dollars to aid other countries, primarily in Africa, to attack the scourge of HIV/AIDS. Section 7601(29) launched the largest ever international public health plan and saved 17 million lives, and it is viewed the most successful American foreign aid program since the Marshall Plan after WWII.

Congress sought to fund only those organizations that have, or agree to have, a “policy explicitly opposing prostitution and sex trafficking” [§ 7631(f)]. This is known as the Policy Requirement. Congress enacted this because prostitution and sex trafficking are degrading to women and children [§7601(23)].

Plaintiff Alliance for Open Society International, Inc. (AOSI) and others are American nongovernmental organizations that receive Leadership Act funds to fight HIV/AIDS abroad. These plaintiffs have long maintained they do not want to express their agreement with the American commitment to eradicating prostitution.

Plaintiffs challenged the Policy Requirement, alleging it violated the First Amendment, and in 2013 the Supreme Court agreed, “concluding that the Policy Requirement ran afoul of the free speech principle that the Government ‘may not deny the benefit to a person on the basis that infringes his constitutionally protected . . . freedom of speech’” [Opinion at 2. *Agency for Int’l Development v. Alliance for Open Society Int’l, Inc.* 570 U.S. 205, 214 (2013)]. American firms can obtain Leadership Act Funds and the Policy Requirement no longer applies to American organizations. Since 2003, foreign organizations receiving these funds remain subject to the Policy Requirement and still must have a policy explicitly opposing prostitution and sex trafficking.

Following the 2013 decision, plaintiffs returned to court in the U.S. District Court for the Southern District of New York that agreed that the Policy Requirement could not be enforced against plaintiffs’ foreign affiliates. The U.S. Court of Appeals for the Second Circuit affirmed but Judge Straub dissented, saying he was startled that the other two judges held the First Amendment could be extended to foreign corporations operating abroad. The Supreme Court granted certiorari, 589 U.S. (2019) and the high court reversed the judgment of the Second Circuit on June 29, 2020.

Justice Kavanaugh says the plaintiffs’ position runs headlong into two bedrock principles of American law. First, it is long settled that foreign citizens outside U.S. territory do not possess rights under the U.S. Constitution. Second, it is long settled as a matter of American corporation law that separately incorporated organizations are separate legal units with distinct legal rights and obligations. The foreign organization may be affiliated with an American organization, but the foreign corporation is legally distinct from the American organization. “In short, plaintiffs’ foreign affiliates are foreign organizations, and foreign organizations operating abroad have no First Amendment rights” (Opinion, p. 6).

Justice Kagan did not take part in this case. Justice Thomas filed a two-page concurring opinion saying the Policy Requirement did not require anyone to say anything.

Justice Breyer, with Justice Ginsberg and Justice Sotomayer, filed a 23-page dissenting opinion.

Just who is AOSI?

AOSI does not have any employees. AOSI promotes the values of open, democratic societies globally. AOSI coordinates, administers, and advises national and regional programs in Central Asia and elsewhere on a range of public health, education, and general civil society issues. It also educates the public about societies’ attempts to become democratic market economies after totalitarian or authoritarian rule.

In the United States it works with the U.S. federal government on charitable projects that address challenges facing urban communities and centers. AOSI makes and receives grants in addition to cooperating with other charitable organizations to achieve these goals.

News media sources are suggesting that Justice Samuel Alito is thinking about retiring from the Court. President Trump may want to make his new list of potential nominees available to voters soon.

## Things Have to Change





## Return of the Wandering Jew

*“There is nothing worse for mortals than a wandering life.” —Odyssey Homer*

BOYNTON BEACH, FL—No, this is not a story about the care and maintenance of a popular houseplant of the same name. It is a tale of a Jew who lived in Jerusalem during the time of Jesus. The origins of the term “Wandering Jew” are somewhat murky, but are believed to originate in Christian mythology somewhere around the 13th century. Condemned to wander the Earth for eternity until Judgement Day for mocking the suffering of Christ, the Wandering Jew has become a metaphor for the fate of the Jewish people for almost two millennia. Over centuries, stories have been told, plays have been written, and in modern times, motion pictures have been made. In one account, he is depicted as a hunchback wandering the Earth in the company of Lucifer; in another, as a harbinger of plague. His perceived arrival or an outbreak of the plague, usually resulted in the extermination or expulsion of the local Jewish community.

The establishment of the modern state of Israel in 1948, following world-wide revulsion over the Holocaust, at last gave all Wandering Jews a place they could call home, returning to their ancestral homeland. Unfortunately, Jew hatred throughout the Middle East and much of the world continued unabated, and the Wandering Jews found no peace. Israel’s victories in its four major wars were hailed as great triumphs; but victory did NOT bring about widespread peace and acceptance among its many hostile neighbors. With the passing of time, Jew-hatred has again reared its ugly head; not just in the Middle East but around the globe. Antisemitism has now gone mainstream. So virulent is this new form, that even foreign heads of state, such as President Erdogan of Turkey and Prime Minister Mahathir Mohamad of Malaysia openly express anti-Jewish and anti-Israeli viewpoints; while across the Islamic world, publications such as the *Protocols of the Elders of Zion* and Hitler’s *Mein Kampf* still enjoy brisk sales. According to recent statistics, antisemitism has exploded around the world at levels not seen since the 1930’s. American Jews in particular, and

most progressive Jewish organizations, as well as the far-left, continually attribute most of this to the rise of the far-right neo-Nazi, and point to the attacks on Jewish houses of worship in Pittsburgh, Pennsylvania and Poway, California as proof. While it is true that the far right has been expanding in recent years, which could be interpreted as a reaction to the far-left tilt of the nation, the numbers according to FBI statistics are relatively small. What HAS expanded exponentially is the growth, power, and influence of both the radical left and Islamists, with an unconventional alliance between them; the ultimate goals of which is the destruction of Israel and the United States.

Most American Jews seem almost blissfully unaware of this turn of events. They cannot break with the leftist belief system of their parents and grandparents, and are unable to recognize that their precious Democrat Party has moved so far to the left, that its allegiance has shifted to those who seek the destruction of the Jewish state, and by extension, the Jewish people. Jews speak of “*tikkun olam*” in reverent tones and claim that they are Americans, not Israelis. They are abandoning the Jews of Brooklyn, America, and Israel.

All too often one hears: “*Israel can take care of itself*”; “*Israel must make major concessions in order to achieve peace*,” “*Israel is a racist apartheid state*,” and “*Jews whine too much about the Holocaust!*” The reality is that Israel is just a minuscule strip of sand along the Mediterranean coast that cannot survive without American aid. Given the shift of the Democrat Party to the far left, the next Democrat president cannot be expected to continue support of such a “*genocidal state*.” Democrat presidential candidate Bernie Sanders has already addressed this issue when he stated he would re-direct all American aid currently received by Israel to the Palestinians. Joe Biden has been endorsed by virulent Jew-haters Ilhan Omar (D-Minn) and Rashida Tlaib (D-MI); both have not condemned Louis Farrakhan who insists Jews are “*termites*” and “*satanic*.” Biden also welcomed the endorsement of J Street, the far-left George Soros-backed group that has opposed most U.S. policies that support Israel, and whose leader embraced Palestinian Authority despot Mahmoud Abbas.

In Biden's current state of mind, he can easily be manipulated by the mounting Jew-hate emanating from the Democrat Party. During a recent demonstration, a small boy was observed holding a placard that read, "*For world peace Israel must be destroyed.*" This is not an isolated sentiment, but a belief widely held by many in the Islamic world and by a substantial number on the far left.

American Jews continue to believe that the American system will protect them. "*We are safe here,*" they claim, and smugly assert that pogroms and expulsions could never happen here. Many are shocked to learn that BOTH already have. In 1991 following the accidental death of a black child struck by a Jewish motorist, mobs of blacks rampaged through the streets of Eastern Parkway, Crown Heights, Brooklyn, incited by none other than Al Sharpton, who screamed Jews were diamond merchants, alluding to their privilege and wealth. Black Democrat Mayor David Dinkins condoned loud shouts of blacks threatening, "*Kill the Jews!*" and "*Death to the Jews!*" Attacking Jews on the streets, looting Jewish stores and breaking into Jewish homes easily identified by the mezuzot on the doorposts, as this "*pogrom*" continued for three days; one Jew named Yankel Rosenbaum was stabbed to death; dozens of others assaulted. As for expulsions, in December 1862, General U.S. Grant issued his infamous General Order #11, expelling Jews from most of Tennessee, Mississippi, and Kentucky.

What has happened before could happen again, in which case that little sliver of coastal real estate on the shores of the Eastern Mediterranean just might come in handy. This is no longer a question of disagreement with policies of the Israeli government—this is about the very survival of the Jewish state and the Jewish people.

American Jewry in short, is torn between conflicting loyalties. In all probability, the vast majority will continue to cling to their ancestral ideology. Jews continue to receive requests in the mail for donations from leftist Jewish organizations calling out right-wing Nazi white supremacist hate, complete with imagery and text showing iconography of swastikas and Heil Hitler salutes that give the impression the threat to Jews comes from one side only. Nowhere in these letters does it mention that progressive Jewish groups are allying with their enemies who are tied to the Muslim Brotherhood and Hamas. When the source of murder, assault, and violence to Jews comes from Muslims and Blacks, the donation request letters illusively describe the assailants as "*thugs*" or "*hate-mongers,*" giving the impression hate comes mostly from white supremacist neo-Nazis.

FBI 2018 Hate Crime statistics show a list of "*offenders*" that includes White, Black, Hispanic, and others, but Islamists are excluded. Are Islamists not perpetrating hate crimes? Anti-Islamic/Muslims, are, though, included in the statistics as "*victims*" of bias hate crimes. Jews encompass only 2% of the total population of the U.S., yet are the victims of 56.9% of all hate crimes. This statistic should be a sobering reminder to every Jew and should dispel the notion that "*We are safe here.*" Does it have to be that you only

feel "*safe*" until such time as something happens to either you or someone you know? It is time for leftist newspapers to print opposing views, warning their devoted Democrat Jewish readers that there's plenty of hate out there coming from ALL sides, and by ignoring these facts, Jews are not able to determine how best to safeguard for their future.

Mainstream media and social media fuel the Nazi narrative and Jews predictably ingest this propaganda 24/7 from most of their rabbis, politicians, academia, and their Torah of choice: *The New York Times*, as if areas like Crown Heights and Williamsburg in Brooklyn and college campuses all over our nation are chock full of KKK and neo-Nazis. A great many of these assaults go under-reported by mainstream media because of the ethnic make-up of the attackers. It is just NOT politically expedient to show Blacks or Muslims beating up Jews. The Democrat Party, after all, still needs the Jewish vote.

Jews historically have been at the forefront of the Civil Rights Movement and many who love to support "*social justice*" embrace Black Lives Matter, but seem unaware that in 2016, the BLM platform denounced Israel for committing "*genocide*" against the Palestinians, ignoring the numerous terrorist attacks directed against Israel from the Palestinian territories. This part of the doctrine has now disappeared from their website and the Internet. Before Jews place Black Lives Matter banners on their Twitter and Facebook accounts, have they asked BLM leaders why part of their agenda is supporting BDS (Boycott Divestment Sanctions) against Israel? If BLM declares, "*Pigs in a blanket, fry 'em like bacon,*" with the goal of defunding cops, is it in the Jews best interest to forsake their own security when Jew-hatred is exploding all around them?

If there is one thing that can unite a neo-Nazi skinhead and a far-left ideologue, it is hatred of Israel and the Jews; and if one thing can unite a Sunni extremist and a Shiite fundamentalist, it is hatred of Israel and the Jews. It will be a perfect storm of Jew-hatred. The process of the delegitimization of the Jewish state has already begun. Many Jews whose progressive ideology is their religion have fallen for it—hook, line, and sinker!

There is no other country in the entire world whose very right to exist is being called into question, nor is there any other country that is held to a standard of behavior that no one else on this planet is called upon to endure. We have to all understand that our enemies look at us not as Israelis, Americans, Britons, Canadians; Liberals or Conservatives; Republicans or Democrats; Reform, Conservative, Orthodox, or non-observant, but ONLY as Jews! 

## Book Review

***Great Society: A New History*, by Amity Shlaes. New York: HarperCollins, 2019. Hardcover, 511 pp. ISBN No. 978-0-06-170642-4.**

The author of *Great Society: A New History*, Amity Shlaes, wrote another well-received book that I read some time ago. That book, *The Forgotten Man*, told the story of the Great Depression and what effect FDR's New Deal policies of the 1930s, meant to correct it, had on American society. It serves as a companion to her latest effort. Shlaes chairs the board of the Calvin Coolidge Presidential Foundation and the Manhattan Institute's Hayek Book Prize.

There were not many self-described socialists in America in the 1960s, but many citizens in the country wanted to improve life for all. In the 1930s, the New Deal had failed to reduce unemployment. The prolonged periods of joblessness were what had made the Depression "Great." But the memory of the New Deal failure had faded just enough that younger people liked the sound of the term. And memories of more recent success fueled Americans current ambitions. Compared with overcoming a Great Depression, or conquering Europe and Japan, eliminating poverty or racial discrimination had to be easy. American society was already so good and this good society had to become, in the words of President Lyndon Johnson, a Great Society.

The question was how to become great. The United States could look to the private sector to change the country. Or it could seek change through the public sector. In the 1960s, over and over again, Americans chose the public sector. The result was a string of federal campaigns conducted in the name of the betterment of society.

The New Deal had expanded the federal government so much that for the first time, Washington had surpassed the towns and cities as a presence in the economy. The reforms of the 1960s seemed to be designed to finish the job, to squeeze the states and towns out of government altogether even as they were being assured that they had nothing to fear from Washington's "New Federalism." [What this meant was that, as was the case in the former Soviet Union,



the power to control the American economy was being taken away from the towns and cities and centralized in Washington, DC.]

Today the 1960s are catching up with us, and the entitlement programs of that era are costing us trillions of dollars that we can't afford. The New Deal created the Forgotten Man, and the Great Society has created even more.

In 2020 the contest between capitalism and socialism is alive and well, which makes one lament about the sad fact that so many of our citizens are not aware that collectivist planners eventually turn the populace toward autocrats. One reason is that many of today's socialists are hiding in plain sight, having taken a lesson from the '60s radical leftist Tom Haden who once advised, "We will be out if we are explicitly Socialists. We can be further 'in' if we call Socialism Liberalism." And another reason is that many have lost sight of Thomas Edison's "bottom up" theory that men who ran their own labs had more ideas than men who were cogs. Put another way, small departments would add more value to a company than any single big project ordered up and scrutinized at each stage by top executives. After all, sometimes valuable ideas were not planned, but discovered almost by accident, as in the case of the surprising discovery of Lexan, a General Electric plastic as hard as metal.

Today, in 2020 the New Deal of the 1930s and the Great Society of the 1960s seem hard to analyze, but easy to reminisce about. If you seek to get a sober and objective analysis of those two eras in America's past and what they've bequeathed us today, instead of reminiscing about them as so many do, Amity Shlaes' *Great Society* is a good place to start.

Obviously it cannot be named for her husband, who ordered the internment of 117,000 persons of Japanese descent, two-thirds of whom were native-born American citizens. And there are hundreds of towns counties and parks and schools named for Washington, such as Washington and Lee University.

Good grief! The name is double hate-speech! Robert E. Lee actually commanded the Confederate Army!

Washington is not the only name progressives should scrutinize. The word Oklahoma is a compound of two words from the Choctaw language, words meaning "red" and "people." If it is intolerable to have a football team named Redskins, it must be worse to have a state named Red People.

But let's get back to cleansing America of all people who are less than perfect progressives. On the Tidal Basin in Washington there's a memorial to the slave-owning Thomas Jefferson. This memorial should have a trigger warning carved into its marble.
